Who is Eligible:

- Comox residents **only** may apply for the TRIP Card.
- Post secondary students are not eligible as they already receive student rates (a form of subsidy).
- The TRIP Card is designed for individuals and families who are working low income, on B.C. Benefits and/or your gross family income cannot exceed the amounts shown on the front of this form.
- Each member of the family is eligible for a TRIP Card. A family includes parent(s) or Guardian(s) and children.

How do I Apply:

- The application form must be completed in full and submit for review and approval to the Comox Community Centre.
- Proof of Comox residency is required. One must be photo id (current DL or BCID etc) and the second a tax notice, utility bill with name & address or other identification with name and address. **BC Care Cards for all applicants, including dependants, are to be provided at time of application.**
- A “TRIP Card” will be provided to each family member and is good for one year from date of issue once all eligibility requirements are met.
- Adults must be present to receive their “TRIP Card” and each adult must verify Comox residency and Care Card number.
- Only one application per year is permitted.
